This record does, however, serve as a tool to help Iowa trade unionists assess whether or not their elected representatives support a agenda that benefits all workers, organized or not.

The Iowa Federation of Labor also scores the Governor's actions so members can understand the record of the executive branch of government. Legislation that the IFL supported or opposed that a Governor signs, vetoes, or line-item vetoes will also be scored as well.

This includes an employee testing positive for any controlled substance for which the individual does not have a current prescription.</p> <p>Previous to this bill passing, the employer must have established that an employee was impaired so as to disqualify the employee from receipt of benefits. There are many problems with the provisions in the bill and it fails to take into account the basic fact that a positive test does not necessarily equate with impairment so as to justify disqualification from benefits.</p>

Instead, within 24 hours of receiving the ABR with missing information the auditors must call, email or mail the voter to be able to input the correct information. Another new voter suppression tactic included in this bill requires an ID when voting early in person.</p>
